THIRTY-FOURTH ANNUAL MEETING

Members of the Society who wanted to attend the ETS meeting on the campus of Northeastern Bible College in Essex Fells, New Jersey, December 16-18, 1982, as well as the meetings of SBL/AAR in New York City, December 19-23, 1982, could do so because of the proximity of the two places.

If not the timing and location of the 34th annual meeting, then certainly the program with the theme "Biblical Criticism and the Evangelical" drew a large crowd. The Society is deeply indebted to Northeastern Bible College for hosting those who attended. More than 325 persons registered for the meeting, and for some of the plenary sessions at least 400 people were in attendance.

Program Chairman Louis Goldberg had invited special speakers, had enlisted numerous participants, and had arranged five plenary sessions with topics ranging from an evaluation of redaction-critical methods in interpreting Scripture to a review of Jewish-Christian relations after the holocaust. Alan F. Johnson delivered his presidential address on "The Historical-Critical Method: Egyptian Gold or Pagan Precipice?"

The secretary-treasurer, during the first business meeting, presented a membership report and a financial report.

The executive committee acted on these matters:

- 1. The thirty-fifth annual meeting will be held in Dallas, Texas, on December 15-17, 1983. The theme is "Preaching and Biblical Exegesis."
- 2. The theme for the thirty-sixth annual meeting, "Evangelicals: Heritage and Rediscovery," features Church history.
- Because of questions raised with respect to Robert Gundry on methodology in interpreting Scripture, the executive committee called attention to the brevity of the Society's doctrinal basis and deemed that this basis does not provide criteria for distinguishing which methodologies are incompatible with the Society's stance on inerrancy.

- 4. Deceased members George M. Elliott and John F. Gates were fittingly acknowledged in a brief memorial service.
- The Society expressed thanks to Alan F. Johnson for his leadership as president.

During the course of the past years, the members of the Society have become increasingly expressive in scholarly pursuits in articles delivered at annual and regional meetings and in publishing books and monographs. May the Lord continue to bless the Society in fostering conservative Biblical scholarship.
