- 3. Be it resolved that deep appreciation be expressed to Talbot School of Theology, Biola University, and to President Clyde Cook, Dean Wendell Johnston, and those who helped with local arrangements.
- 4. Be it resolved that we commend the Evangelical Philosophical Society and the Near East Archaeological Society for their quality collateral programs.
- 5. Be it resolved that, in view of the critical issues discussed in these meetings with regard to Church and society, we urge continued active involvement of each member of the Society in confronting these crucial challenges and opportunities.

President Gleason L. Archer announced the schedule for the thirty-eighth and the thirty-ninth meetings.

- 1. The thirty-eighth annual meeting will be held in Atlanta, Georgia, November 20–22, 1986. Theme: "Man and Woman in Biblical and Theological Perspective."
- 2. The thirty-ninth annual meeting will be held in Boston, Massachusetts, December 3-5, 1987. Theme: "Evangelicals and Spirituality."

The Society adopted an amendment to the Constitution by adding a second paragraph to Article IV, Section 4:

A member whose writings or teachings have been challenged at an annual business meeting as incompatible with the doctrinal basis of the Society, upon majority vote, shall have his case referred to the Executive Committee, before whom he and his accusers shall be given full opportunity to discuss his views and the accusations. The Executive Committee shall then refer his case to the Society for action at the annual business meeting the following year. A two-thirds majority vote of those present and voting shall be necessary for dismissal from membership.

Paul L. Kaufman, S. E. Murray, Michael W. Narkun, Glenn O'Neal, Louis Praamsma, Merrill C. Tenney and Jack Zandstra.
