

THE NEW TESTAMENT AND GRECO-ROMAN RHETORIC: A BIBLIOGRAPHICAL UPDATE

Rhetorical criticism continues to grow as a subdiscipline of Biblical studies. As the rhetorical discipline defines itself more precisely, as more sources come to light in new studies, and as new works themselves proliferate, the need for collecting bibliographical references mounts.
